<u>TAX ABATEMENT – OAK VIEW TOOL</u> David Eizelman, President of Oakview Tool, provided background information on Oakview Tool, their vision for the company and the plan to change their name to SGS Specialty Group. He shared their plan for this year was to hire a total of 7 people to handle the new opportunities they have and by 2019 to have doubled their business and have a combined total of 19 new employees.

Jeff Walker advised he distributed the request to Council for consideration. He stated it was for a traditional 10 year abatement with a 10% sliding scale every year for the 10 years. He explained the Tax Abatement Committee met and once they did the scoring it more than exceeded the requirement and criteria for points to be considered for the tax abatement. He shared that, collectively, they felt a very positive recommendation for the 10 years was in order because of the growth and continued strategies that the company has put forth to continue with hiring good paying jobs.
