## AGREEMENT FOR GROUNDWATER MONITORING – WAYNE RECLAMATION: BURGESS & NIPLE Rosie Coyle explained this agreement was for the monitoring of the Wayne Waste site. She advised it was up \$300.00 from last year. She noted they do a great job and have been doing this for years.

Motion was made by Walt Crowder to approve Proposal No. 21-1001 as presented, Nicole Penrod seconded the motion, all voted aye.

## RESOLUTION NO. 2021-4: UTILITY SERVICE BOARD CONTRACT WITH

**IMPA** Motion was made by Nicole Penrod to read Resolution 2021-4 by title only, Walt Crowder seconded the motion, all voted aye. Clerk Treasurer Rosie Coyle read Resolution 2021-4 a resolution of the Utility Service Board of the City of Columbia City, Indiana, approving amendment of the power sales contract with the Indiana Municipal Power Agency.

Mayor Daniel advised IMPA has requested an extension to their sales agreement with the Columbia City Municipal Electric. He explained, as the Board of Public Works, this Board operates as the Municipal Electric Utility Board and advised the agreement would also go in front of City Council. He noted this was an extension until 2042.

Nicole Penrod questioned the dates in the resolution. Mayor made a correction and noted the current agreement expires in 2042 and the extension is until 2050.

Motion was made by Nicole Penrod to approve Resolution 2021-4 for the contract with the Indiana Municipal Power Agency, Walt Crowder seconded the motion, all voted aye.

**<u>BILLS</u>** Motion was made by Nicole Penrod to pay accounts payable vouchers dated February 23, 2021 in the amount of \$931,542.71, Mayor Daniel seconded the motion, all voted aye.
