## SECURITY LIGHT AGREEMENT

**WHO IS ELIGIBLE?** Any customer on the Columbia City Electric Department distribution lines desiring a security light service from existing lines.

WHAT IS FURNISHED? Utility will install, own and operate the lighting unit installation, including all necessary appurtenances to properly control same. Such installations will be made by the utility and shall include, if necessary, one additional pole and/or extension of Utility's 120 or 240 secondary conductors up to a maximum distance of 150 feet. The customer shall pay for the cost of any additional facilities. Installation will be on Columbia City's poles.

WHO TAKES CARE OF THE MAINTENANCE? The Columbia City Electric Department supplies the fixtures, current used, and maintains unit as needed. The consumer shall notify the Utility when a light does not operate properly so that repairs can be made at the Utility's earliest convenience.

CHARACTER OF SERVICE- The lighting unit will be an LED type luminary. The lighting unit will be photoelectric controlled to provide year around dust to dawn lighting service. For general purpose lighting (back yards, side yards, and alley ways) a standard LED security head will be used. For commercial parking areas or larger residential areas, a Cobra head or Flood luminary with 60–400 watt LED light will be used, depending on customer request. (Submit drawing indicating locations of lights for any parking lotswe will work with you if needed on locations)

**TERM OF SERVICE**- Any customer requesting service under this rate shall make written application for such service for an initial period of *ONE* year and such service shall continue from year to year thereafter unless cancelled by either party.

**PAYMENT AND BILLING-** The monthly charge per lamp will be included on Consumer's monthly bill and the payment of same shall be subject to the same terms of payment as are applicable to Consumer's bill for regular metered electric service.
