# CHAPTER 01 EXECUTIVE SUMMARY

#### **PURPOSE OF THE PLAN**

The purpose of this planning effort has two main goals. First, it will provide a strong vision to guide downtown planning, decision making, and development for the next five to ten years. Second, it will ensure downtown Columbia City is prepared for future funding opportunities as they arise.

Columbia City cannot be written off as a sleepy Indiana town. The downtown has active festivals throughout the year that draws thousands of participants and a number of lively shops and eateries. Local special interest groups have devoted their time, and in many cases, manual labor towards beautification of the streetscape and renewing older buildings and encouraging entrepreneurs to inhabit them. This combined vested interest in the success of downtown from both the city leadership and the community is visible and vibrant.

Alongside Columbia City Connect, the City of Columbia City can use the implementation plan at the end of this document to guide next steps and initiatives. Potential state and federal revenue streams and programs may present themselves in the coming years—the intent is for Columbia City to be ready to capture those opportunities.

## **STUDY AREA**

The plan focuses on city blocks surrounding the Whitley County courthouse square. The area is bound by Jefferson Street to the north, Vine Street to the south, Walnut Street to the west and Washington Street to the east. At the southeast corner, the study area touches the Blue River.





The Steering Committee led a walking tour during the planning process--here reviewing one of the many vibrant local businesses within the blocks surrounding the square.



## **PLANNING PROCESS**

The five types of public engagement included in the planning process are outlined below—a more detailed account of the input received is included in the Public Input chapter within the plan:

- Steering Committee Meetings: A committee made up of downtown business owners, city leadership, life-long residents, and several professionals who have relocated to Columbia City from larger cities met regularly throughout the planning process.
- Stakeholder Interviews: Teenage residents from the Mayor's Youth Council, active downtown advocates, and downtown business owners were the three groups of stakeholders who were interviewed separately as a part of the project.
- Online Public Survey: An 18-question survey was made available to the public via social media from early-June to mid-August. 425 people responded to the survey within that time. Questions were focused to first gain a better understanding of the demographic responding and secondly to help determine priorities of the participants regarding present conditions as well as the outlook for downtown Columbia City.
- Downtown Public Outreach Event: A public input booth was set up at the First Friday event on August 4th, 2023. As residents of Columbia City, as well as neighboring communities, enjoyed food vendors, booths, and live music, they were invited to participate in public input exercises.
- Public Presentation: The plan was presented at both the Redevelopment Commission meeting and the Columbia City Council meeting on November 14th, 2023.

#### **KEY FINDINGS**

Key takeaways from public engagement:

- Residents go downtown most often for community events and dining.
- Visitors want more dining and shopping options but not more events.
- Cars get them there, but other options would be desirable.
- Visitors want to enjoy outdoor spaces.
- Dining, shopping, and entertainment are in the greatest demand.
- Downtown is the heart of the community

Common themes that rose to the top in discussions with downtown advocates and entrepreneurs:

- Remove angled parking from busy streets surrounding the courthouse square
- Make parking more convenient/ accessible for new businesses, restaurants, and residents.
- Recruit upscale dining options
- Improve streetscape by providing consistent lighting, better maintained trees and grates, and providing matching signage
- Require property owner accountability for building conditions and upkeep

Top six desired downtown amenities:

- Indoor Play Space
- O Downtown Trails
- Play Sculpture
- Interactive Lighting
- Interactive Fountain
- o Food Truck Court

# **GOALS & STRATEGIES**

Because so many of the "little things" have already been accomplished here—successful facade programs, activated alleys, well-attended events and programming, the establishment of an arts council and the implementation of several public art installations—plan recommendations push the community towards a next "big" thing.

After reviewing past planning efforts and recent accomplishments, analyzing public input, and inventorying existing conditions, recommendations were developed in four main categories—CONNECT, ATTRACT, PROTECT, and INFORM.

## **USING THE PLAN**

This plan is intended to be used as a guide for key decision makers over the next five to ten years to shape the future success of the downtown. Strategies and immediate next steps are outlined with assigned responsible parties within the implementation table in the Recommendations chapter. Intended to provide high level guidance, implementation in many cases will lead to more detailed studies and further development of recommended construction projects, policies, and programming.




FIGURE 1.1: PLAN RECOMMENDATIONS

# **COLUMBIA CITY PLANNING EFFORTS**

# PAST PLANS

Past planning documents provide valuable insight into where the community was and how it has evolved. The following documents range from parking studies to a past city-wide comprehensive plan. Examined in chronological order, these studies inform the current Revitalization Plan with what goals were set, if they were met, and how to adjust future goals to continue the community in a forward motion towards progress.

# DOWNTOWN PARKING STUDY (1992)

In response to the Americans with Disabilities Act of 1990, a downtown parking study was commissioned to analyze the parking conditions at the time, access accessibility, and provide solutions to improve accessible parking. The study encompassed the downtown area bounded by Jackson Street, Washington Street, Spencer Street and Walnut Street. The city has since improved parking configurations, quantity of accessible spaces and placement of accessible spaces to accessible routes to meet ADA requirements. The purpose of this study was strictly to address ADA requirements, and therefore no conclusions were drawn as to the analysis and solutions to parking zones, time limits or available parking to downtown business and residents identified as concerns in the Comprehensive Plan. A study of this nature could be beneficial in the city's endeavor to revitalize downtown.

# **REVITALIZATION STUDY (1993)**

This study was the culmination of a collaborative effort between city agencies and downtown businesses to revitalize the City's downtown by identifying specific concerns, issues, goals, and objectives to make recommendations for façade and streetscape designs. The Study identified the need for a financial incentive program and visualized conceptual façade, streetscape, and clustering designs.


Culminated in the recommendation of a Five-Year Action Plan the following goals are addressed: maintaining downtown business stability, encourage business expansion, improve diversity and new development; improve aesthetics and pedestrian safety; improve existing residential properties and develop new ones; provide leadership for downtown revitalization efforts; improve street signage; and increase downtown activities and programs to attract visitor and residents.

Twenty-two years later, many of these issues have been addressed with façade improvements and redevelopment but the continued identification of these same issues in the 2015 Comprehensive Plan indicates these goals have not all fully been met.

# FACADE IMPROVEMENT GRANT PROGRAM (2005)

The purpose of this program is to provide funds to improve the street appearance of the commercial and business facades to help stimulate the business environment of the downtown as identified in the 1993 Revitalization Study. The program provides grant assistance to businesses for façade improvements, awnings, signage, and lighting. Building facades play an important part in a city's streetscape and maintenance of historic facades further enhances a city's historic and cultural heritage.





Columbia City Comprehensive Plan (2015)

#### **COMPREHENSIVE PLAN (2015)**

The most current Comprehensive Plan was adopted in 2015. A moderately sized, rural community in northeast Indiana, Columbia City has experienced moderate growth and economic stability without denying its small-town identity. To meet the city's need to compete with changing social and economic trends, the Comprehensive Plan proposed improvements and "leveling up" its existing community assets.

Revitalization of an underutilized downtown square was a primary focus of the Plan. In 2015, the downtown was described as a blank

slate with buildings vacant, underutilized or in disrepair. Recommendations included rezoning to Mixed Use from the existing Central Business District to allow multi-family housing opportunities, development of a downtown satellite campus for higher education, and increased opportunities for restaurant and retail businesses and business Although the downtown remains incubators. zoned as Central Business, the downtown area could no longer be considered a "blank slate". Murals and street art can be found in activated alleys and spilling out into the sidewalks, buildings have high occupancy offering a range of restaurants, shops, and small businesses, and programming around the square brings people to the square throughout the year.

Several recommendations from this plan are still applicable today including pursuing mixed use housing opportunities downtown, create a citywide public art master plan, create a gateway and wayfinding signage master plan, create a downtown streetscape master plan, create a downtown link for the Blue River Trail, and establishing a visual standard downtown by reviewing existing policies and guidelines.

#### **REDEVELOPMENT STUDY (2016)**

This study narrowly focused on the redevelopment of a vacant property bordered by W. Van Buren Street and N. Line Street as a three-story, mixeduse workforce housing apartment building. The recommended solution for a three-story mixeduse low-income housing apartment building with first-floor retail space, a community room and garden space has since been constructed and is open for leasing. Projects of this type were identified in the Columbia City Redevelopment Initiative and Comprehensive Plan for revitalizing downtown and provide a blueprint for future such developments.

### **PROJECT STUDY AREA**

This plan focuses on city blocks surrounding the Whitley County courthouse square. The area is bound by Jefferson Street to the north, Vine Street to the south, Walnut Street to the west and Washington Street to the east.

#### THE NORTHERN BOUNDARY

The northern boundary, two blocks north of the square to the Whitley County Historical Museum, encompasses three large, downtown churches. One of these churches was uniquely restored and is now home to an established retail store, The Shops @ the Sanctuary (pictured bottom right).

#### THE EASTERN BOUNDARY

The eastern boundary extends one block east of the square, capturing the one- and two-story buildings along Main Street, and includes a fair amount of residential areas.

#### THE WESTERN BOUNDARY

The western boundary, two blocks west of the square to the Marshall Community Center, includes three-story commercial buildings and the new mixed-use development along Van Buren Street. South of the square, this western edge extends one block west, capturing residential parcels as well as two downtown churches- one retrofitted currently as The Center for Whitley County Youth.

#### THE SOUTHERN BOUNDARY

The southern boundary extends three blocks south to the Blue River, connecting to the Blue River Trail and establishing an anchor for a southern gateway into downtown. This zone south of the courthouse square also includes an industrial site prime for redevelopment.


## **BUILDING DENSITY**

Building density in the study area varies block to block with some blocks having a few larger buildings and others having many large, medium and small buildings. The residential areas are in close proximity to the downtown square, in some cases only one block removed.

Larger, three-story historic buildings are focused along Van Buren Street mostly with retail and commercial on the main level. Some have successfully established living quarters or vacation rentals on the second and third floors, but many sit vacant due to development codes making conversion costly.

One- and two-story buildings are focused along Main and Market Street largely comprised of retail/commercial business with some buildings being historic in nature. The two exceptions being the three-story automotive building located southeast of the Market-Main intersection and the one-story Whitley County Jail located southwest of the same intersection. City Hall, with three stories, creates a presence at the northwest corner of the Market-Chauncey intersection.










FIGURE 2.1: PROJECT STUDY AREA

## **PUBLIC GREEN SPACE + PLAZAS**

The project area does not include any defined parks; however, there is a parklet located south of Van Buren Street between Line and Chauncey Streets along the alley known as Thomas Marshall Plaza.

The alley north of this site is activated as a pedestrian thoroughfare – including paver walks, a mural, and security bollards – in conjunction with the Whitley County Government Center. This location hosts "Art in the Alley" events.

Another activated alley, Ohki Alley, exists directly north of the square off Van Buren between Chauncey and Main Streets. This alley is a true pedestrian plaza with murals, outdoor seating, planters, and overhead lighting. The main green space in downtown exists on government property with the largest being the courthouse square lawn. City Hall has a nice lawn and plantings outside the main entry that encompasses the southeast corner of the block.

### **PROPOSED PARK**

In 2020, the old Columbia City High School property was turned over to the Columbia City Parks and Recreation department for the development of a new, 56-acre park adjacent to the Russel and Evelyn Fahl Aquatics Center. The City worked with the design team of Jones Petrie Rafinski and Moake Park Group to create a masterplan for this community park. Upon completion, the park will include amenities like a recreation facility, outdoor amphitheaters, several playgrounds, various athletic fields and trails to name a few.

## LAND-USE

Planning and Zoning for Columbia City is provided jointly alongside Whitley County and includes the communities of Columbia City, Churubusco, South Whitley and Larwill. The Whitley County online zoning map, powered by Beacon, identifies the downtown area as CB, Central Business District. The district is defined by Walnut Street, Jackson Street, Whitley Street, and Spencer Street. Established zoning districts are defined in Columbia City's Zoning Ordinance.

The majority of the study area is located within the CB district, with properties between Jackson Street and Jefferson Street zoned LB, Local Business, and R-3, Multiple-Family Residential. This is depicted in figure 2.2 at the parcel level.

One of the greatest uses in downtown has to do with "Tax-Exempt" services indicated as dark orange parcels in the map to the right. These services include governmental buildings - at both the county and city levels as well as religious institutions.

One of these uses, the current Whitley County Jail located on the eastern half of the block south of the Courthouse Square, could see a change in use as a new jail is currently being developed outside of downtown Columbia City. This parcel could be an opportunity for acquisition by the City to expand public uses through collaborative efforts with appropriate parties for development that benefits the vision for downtown.



## GATEWAYS

A welcoming entrance sequence into downtown is not well defined from any of the four cardinal directions today; however, with strong residential areas surrounding the district, the potential is great.

As travelers approach downtown Columbia City from the south, the top of the courthouse rotunda can be seen above the tree tops. Shortly thereafter, the impressive educational campus--a recently built showcase for the communitycomes into view. Once past the railroad tracks, the views begin to quickly degrade to treeless roads, utility lines and lighting, and ample parking lots. The vehicular bridge over the Blue River has potential to become a primary south gateway for downtown. Lighting, landscaping, identity signage, and strong trail connections would greatly improve this arrival sequence.

From the north, travelers access the downtown from U.S. Route 30, a main thoroughfare between Columbia City and Fort Wayne. Commercial development continues to grow in this location. A stronger connection between this commercial area and downtown would benefit the adjacent neighborhood and should be encouraged here.

East and West Van Buren Street (State Road 205) offer tree-lined streets and consistent sidewalks leading up to the downtown. Traditional ornamental lighting begins at Washington Street (from the east) and Walnut Street (from the west) but is the only mechanism by which to define the transition between the residential area and downtown. An identity marker, art installation, or monument sign with landscaping and lighting are lacking here.




FIGURE 2.3: GATEWAYS & VEHICULAR CIRCULATION

#### PARKING

#### **ON-STREET PARKING**

All streets within the project area maintain onstreet parking-most on both sides of the street. Angled parking is prominent around the square and one block west of the square on Van Buren Street. Parallel parking is consistent on Main Street and on most blocks as they transition into neighborhoods. On-street angled parking on the south side of the courthouse is currently reserved for county employees. Once the jail relocates, on-street angled parking currently reserved for police cars on the south side of W. Market Street will free up for public use.

#### **OFF-STREET PARKING**

Parking lots are prevalent downtown-some public, some private, and some shared-use. As more second stories are developed into housing and vacation rentals, resident and overnight guest parking options will need to be explored. Access to parking lots for pedestrians is easily navigable from the square via clean, decorated alleys north of Van Buren Street.

# **PEDESTRIAN CIRCULATION**

#### SIDEWALKS

Although sidewalks are in good condition and sidewalk concrete has been repaired and replaced over time, many pedestrian ramps do not meet current standards for accessibility with steeper than allowed slopes and the lack of truncated domes. On busy roads such as Van Buren Street and Main Street, crosswalks are long and not particularly well marked. Replacing the signalized intersection at Chauncey and Van Buren could reduce vehicular speeding on this busy corridor.

#### TRAILS

The Blue River Trail enters the study area along the Blue River at S. Main Street. An existing trailhead sits just southeast of the study area providing parking, restrooms, and trail access to residents and visitors. Additional phases of the trail are underway to make connections south to the educational campus and residences.




FIGURE 2.4: PARKING & PEDESTRIAN CIRCULATION

# **VEHICULAR CIRCULATION**

Main Street acts as a collector roadway for downtown, but also a principal arterial roadway for the broader region existing as State Road 9. This state-run roadway makes streetscape redesign downtown challenging as state roads will not allow curb extensions or bumpouts. Van Buren Street acts as a collector roadway for Columbia City, and also a principal arterial roadway for the broader region existing as State Road 205. Unlike Main Street, this state-run designated roadway stops at the intersection of Main and Van Buren Streets, allowing more opportunities for creativity in streetsape design.

Alleys within the study area are serving as access and connection points for vehicles predominantly. Improvements to the alleys to encourage pedestrians use for easier access to destinations and parking should be considered, similar to Ohki and the Government Center Alley.

# UTILITIES + INFRASTRUCTURE DRAINAGE

#### STREET AND SEWER

Mechanisms to heat the concrete were installed within a recent sidewalk improvement project near city hall that has helped prevent ice and snow buildup and decreased the need for upkeep by shopkeepers. Heated sidewalks throughout downtown would improve safety and reduce maintenance for business located there.

Street closures for festivals and events occur regularly downtown. It was suggested a more permanent system for street closures would eliminate the need for hauling barricades back and forth from storage. Retractable bollards



within the pavement and swing gates should be considered. Fire access would need to be maintained if these options are considered.

It was noted light poles along the streetscape have been hit in several locations downtown due to turning movement of semi-truck traffic. Modifying the parking type—parallel versus angled—to provide more adequate turning movement space and improve visibility was discussed as a potential solution to this on-going issue.

#### STORMWATER AND WATER

One long term goal is to separate sanitary and stormwater utilities downtown. There are current plans for a new line along Chauncey from Spencer to Market. As streetscape improvements are proposed in the project area, the separation of these utilities should be included in those projects. Additionally, many water mains and service lines within the study area need to be replaced due to the presence of lead. Although there isn't a current plan for replacement, this work should be included in any streetscape work that may be planned in the future.

#### **INFORMATION TECHNOLOGY**

Free, public WIFI is currently available downtownthis was implemented in 2022. The addition of security cameras along W. Van Buren St. is desired to provide better surveillance for safety during inactive hours as well as during festivals and events.

#### FIRE

The poor structural condition of many of the downtown buildings is of grave concern to the local fire department. Some downtown structures are in such disrepair, the department would not feel comfortable sending firefighters inside if a fire were to occur.

#### **STREETSCAPE**

#### LIGHTING

Green ornamental poles with acorn luminaries are present throughout the study area; however, the fixture type and pole vary due to manufacturing availability issues. Hanging baskets with annuals and flags adorn some poles. The key to the successful presence of this type of feature in a downtown is consistency.

#### HARDSCAPE

The majority of the pedestrian hardscape areas are standard concrete. Bumpouts, or sidewalk area extending into the restricted parking areas at intersections, exist at N. Line Street and N. Chauncey, which narrow the crosswalk and provide better visibility of pedestrians for vehicles and vice-versa. A narrow paver strip exists along many blocks downtown. The pavers appear worn and faded with settling issues here and there.

#### STREET TREES

In some locations, where a tree species appropriate for an urban context was selected, trees have matured without growing into buildings, and are providing shade and seasonal interest for downtown patrons. In other locations, trees have died, not been replaced, or been removed to provide better visibility to buildings. Empty tree grates remain leaving long, shadeless stretches of sidewalk.

#### **SITE FURNISHINGS**

Outside of the occasional bike rack and litter receptacles, most site furnishings such as benches, outdoor dining tables, and freestanding planters, are left up to the store-owners creating an eclectic feel along some streets and a lifelessness along others where the sidewalks are more bare.

# **CULTURAL AND SOCIAL CONDITIONS**

## **DOWNTOWN EVENTS**

The following events occur on regular, seasonal, and annual bases in the downtown study area:

#### **FIRST FRIDAYS**


On the first Friday of every month from May through October, the downtown becomes a street festival for all ages with entertainment, music, food, and activities for kids. Hosted by Columbia City Connect, this event sees thousands of attendees. An ever-growing, popular event, the festival closes multiple city blocks to vehicles allowing pedestrians to celebrate in the streets throughout the summer evenings.

#### WHITLEY COUNTY FARMERS MARKET

Every Saturday during the warmer months, the Whitley County Farmers Market in downtown Columbia City offers farm fresh produce and jams, baked goods, crafts, and ready-to-eat foods along with programs for kids and live entertainment. This event is held on Chauncey and Market Streets around the Courthouse.

#### **OLD SETTLERS DAY FESTIVAL**

Every June, the city hosts an annual multi-daylong Old Settlers Days Festival with rides, food, and craft vendors on the courthouse lawn, and the American Legion Parade through downtown with similar street closures to that of First Fridays. The festival theme changes yearly.

## **CULTURAL INSTITUTIONS**

Multiple cultural institutions exist downtownthose described below are within the study area:

#### WHITLEY COUNTY HISTORICAL MUSEUM

The museum is in the home of Thomas Riley Marshall, the 27th governor or Indiana and the 28th Vice President of the United States. The museum celebrates Mr. Marshall's life and the history of Whitley County with exhibits, tours, and informative programs.

#### COLUMBIA CITY HAUNTED JAIL


USA Today's number 5 ranked haunted house in the nation, the Columbia City Haunted Jail is located one block east of the courthouse. The building was a functioning jail built in 1875 but was re-purposed in 1991 as a haunted house. Visitors line up to be terrified by elaborate decorations and live villain actors every October.

#### OHKI ALLEY

Named after a local entrepreneur and community leader Shinzo Ohki, Ohki Alley is located north of the courthouse square between North Main Street and North Chauncey Street and features a rain garden, artistic bike rack, flexible seating, beer garden, murals and mobile planters for family entertainment and outdoor dining.

#### **INDIGO STUDIO**

Located inside Brew'Ha Coffee House, between East Jackson Street and East Van Buren Street, Indigo Studio is an all ages arts bar open to the public for painting, arts and crafts classes. Participants are offered a variety of projects to challenge their creative instincts in a fun, stressfree environment. The studio is also available for

birthday parties and other special events. Its first studio opened in Fort Wayne in February 2023 and then the second followed in Columbia City in March 2023.

#### THOMAS MARSHALL PLAZA

Thomas Marshall Plaza, named after Vice President Thomas Marshall, is a pocket park on West Van Buren Street between South Line Street and South Chauncey Street. Situated in the mid-block alley, the park was created as a beautification project in 2015 in response to increased vacancies in downtown buildings and general decline. The plaza features tables, benches, a brick walking path, colorful flowering shrubs and perennials, and shade trees, welcoming patrons to the local businesses.



# CHAPTER 03 MARKET CONDITIONS

# POPULATION

## GROWTH

As shown in the table below, Columbia City's 2020 population was 9,892, a 9% increase from 2010. Columbia City has outpaced the growth of the State of Indiana (5%) and outpaced the growth of the city's regional counterparts. Looking forward to 2028, ESRI projects that Columbia City's population will continue to grow to an estimated 10,128 people. Columbia City's daytime population is 95% of its total population, indicating more people leave Columbia City each day to go to work than stay or enter the city.

# HOUSEHOLDS

As indicated in the tables below, the number of households in Columbia City increased 12.3% between 2010 and 2020, as average household size has decreased (-3.4%). Given this trend, if population continues to grow as it has, demand for housing units may outpace population growth.


# **CHANGE IN HOUSING UNITS**

The table below illustrates the change in total housing units over time for Columbia City, the State of Indiana, and its regional peers. According to Esri's 2023 projection, Columbia City has an estimated 4,605 housing units. Looking at housing unit growth between 2000, 2010 and 2020, growth in housing units has slightly outpaced population growth. Between 2010 and 2020, Columbia City's population grew by 9% and housing units grew by 10%. When accounting for the trend that household size is shrinking (-3% '00-'20) and population is growing (+25% '00-'20), housing unit demand can be expected to continue to outpace population growth.

# **OCCUPANCY CHARACTERISTICS**

The table to the right illustrates the occupancy characteristics of Columbia City's estimated 4,605 housing units in 2023. 3,349 units (73%) are owner-occupied, 1,026 (22%) are renter-occupied and 230 (5%) are vacant. Columbia City has a far higher percentage of owner-occupied units than the state average and its peers. The city also has fewer vacant units as a percentage of total units, when compared to peers. While high homeownership is a positive in many ways, rental demand greater than supply may raise rental costs, thereby potentially limiting who can afford to live in Columbia City.

# COST-BURDENED HOUSEHOLDS

The table to the right illustrates the percentage of households whose gross rent is greater than 30% of their income. A cost-burdened household is considered to be a household that spends more than 30% of its income on rent. A household that is cost-burdened may have difficulty affording necessities such as food, clothing, transportation, and medical care. Nearly 32% of Columbia City's renters are cost-burdened, 10% higher than the State average and higher than its regional peers.

The more income that is spent toward rent, the less income that can be spent frequenting local businesses. There is also an important link between cost-burdened renters now and homeownership in the future. A high number of cost-burdened renters may lead to a lack of future home ownership. This is because a cost-burden renter has less available monthly income to save and, therefore, is less likely to have the needed capital to purchase a home. Thus, if a community wants to increase future homeownership, the current availability of affordable rentals plays a key role.

# **DEMOGRAPHICS**

# AGE

The figure below and at the right show that nearly 25% of the city's population are Millennials, a higher proportion than regional peers. This presents an opportunity for the city to develop the amenities desired by Millennials to retain them as long-term residents. Columbia City also has a significant aging population of 18%. From a residential development perspective, Millennials are entering the prime home-buying age and are looking for products and amenities that are similar to that of Baby Boomers, such as smaller homes, requiring lower maintenance, and walkable access to amenities like parks, shopping and dining options.

## INCOME

Columbia City's 2023 median income, as shown in the figure below, is estimated by Esri to be \$56,664. This number is lower than the State of Indiana (\$65,069) and Whitley County (\$67,442). Additionally, a smaller share of Columbia City's population has a household income above \$75,000 compared to Whitley County and the State. There may be several consequences to having lower household incomes, such as residents having less money to spend at local businesses.




## 2023 Median Household Income

## **EDUCATIONAL ATTAINMENT**

The figure below shows the distribution of educational attainment of Columbia City's residents in comparison to the State of Indiana and its regional peers. When compared to the State and its regional peers, Columbia City has a higher level of bachelor's degree attainment at 23%. When combined with the city's relatively high unemployment, this provides an opportunity for Columbia City to pursue a strategy to attract high-skill, high-paying jobs.




#### 2023 Education Attainment

## UNEMPLOYMENT

An unemployment rate of 4.3% (shown in the figure below), nearly a percentage point higher than the State, suggests that Columbia City has an available labor force and is well positioned to attract new employers, relative to its peers.

## WORKFORCE CIRCULATION

The figure below shows the inflow, outflow, and circulation of workers in Columbia City. Each day approximately 2,865 people commute into Columbia City to work, 3,629 people leave Columbia City to work, and 542 both live and work in Columbia City. As indicated earlier by Columbia City's daytime population of 95% of the total population, more people leave Columbia City each day for work than come in or circulate. This presents an opportunity to attract employers who may hire people who would be more inclined to stay closer to home for work. Additionally, if more people commuted into Columbia City, downtown businesses may benefit from the increased traffic.

# **ECONOMIC BASE & ASSETS**

## MAJOR EMPLOYERS FOR WHITLEY COUNTY

The Whitley County Chamber of Commerce & Visitor Center reports 684 total employers in the county and 255 chamber members. As is evident in the list to the right, most of the county's largest employers are located within Columbia City or in close proximity in Whitley County.

At the County level, manufacturing is by far the largest employment sector (5,960 jobs), making up almost 50% of total private employment. Federal, State, and Local Government employment is the second largest sector (1,451 jobs), followed by Retail Trade (1,224 jobs) and Health Care and Social Assistance (1,020 jobs).

## MAIN STREET SMALL BUSINESSES

The courthouse square and larger downtown area are home to a number of local, small businesses. These businesses include diverse restaurants. a local brewing company, a bakery, a coffee house, and an ice crème shop. The downtown core is home to numerous retail stores, including those focused on antiques, furniture, clothing and shoes, comic books, jewelry, floral arrangements and more. Personal service businesses include salons and a tattoo parlor, and the many professional services include banks, law offices, real estate, insurance, and medical offices. These small businesses are supported by city and county government officials working in the downtown area, nearby residents, and those living across Whitley County and beyond.

## EXISTING LOCAL ECONOMIC DEVELOPMENT TOOLS

Columbia City has a Redevelopment Commission (RDC) that was created by an ordinance of the Common Council. The RDC included five voting members and an ex-officio member appointed by the Whitley County Consolidated Schools board. The RDC has created three Tax Increment Financing (TIF) districts to help attract and incentivize economic development in certain parts of the city. The RDC administers a façade improvement grant program to improve the appearance of commercial properties in the downtown. The RDC also purchases property on occasion to help remove blighted or neglected properties and better prepare them for redevelopment and reinvestment.

The Whitley County Economic Development Corporation (EDC) maintains a revolving loan fund and offers three specific loan programs: Microloan Fund, Community and Small Business Fund, and the Growth Venture Fund. Like the City's façade improvement grant program, the number of applicants and ultimate value of funding awards varies year to year.



## COMMERCIAL DEVELOPMENT OPPORTUNITIES

Several commercial development opportunities are present within the study area, but overall, first floor occupancy is very high. Recent and ongoing infill development projects have occupied vacant sites and surface parking lots with new residential units. Several surface parking lots with development potential remain. While parking supply to the downtown area is important, infill construction on these lots has the potential to create new and modern commercial spaces and significantly increase the value of these properties. Another significant development opportunity is the current Whitley County Jail site just south of the courthouse. During the planning process, a new Sheriff's Department and Detention Center was under construction. Once completed, the current jail will close and become a significant redevelopment opportunity. This is discussed in more detail in Chapter 06.

While first floor commercial occupancy is high, many of the occupants are professional offices that don't rely on visibility or foot traffic. Improvements to upper stories may facilitate relocation of first floor offices up off the ground level, thereby creating openings for new retail, restaurant, and entertainment uses.

## **DESIRED COMMERCIAL USES**

A community survey was administered early in the planning process and completed by more than 400 participants. The top two responses to the question of "What do you wish was offered or improved upon downtown?" were "more dining options" and "more shopping and entertainment options" by a wide margin. The following table lists the types of businesses survey respondents would like to see in the downtown. More detailed survey results can be found in Chapter 04: Public Input.

# CHAPTER 04 PROCESS & ENGAGEMENT

## **PUBLIC INPUT SUMMARY**

Columbia City residents, downtown advocates, and leadership were enthusiastic about providing input for this plan. There is a consistent, collective desire to see downtown Columbia City continue to move forward in a positive direction. Public input for this plan was gathered through steering committee meetings, stakeholder interviews, city leadership interviews, an online public survey, at a downtown public outreach event, and a public presentation. A summary of each type of public input is included in this chapter.

## **STEERING COMMITTEE MEETINGS**

Steering committee meetings were held on June 13th, July 20th, and September 12th. The committee was made up of ten members including downtown business owners, city leadership, lifelong residents, and several professionals who have relocated to Columbia City from larger cities.

Steering committee members used words like "neighborly", "comfortable", "safe", and "affordable" to describe Columbia City today. Although not negative in connotation, these words don't scream "downtown destination with unique character and vibrant quality", which is something the committee feels downtown could be.



Although maybe not quite there, recent wins are encouraging:

- Arts Commission started this year
- Highly successful First Friday events going strong for 8+ years and counting
- Good mix of older businesses and newer trendy shoppes
- Robust façade grant program
- Coffee shop, brewery, ice cream, and several eateries within walking distance from the square
- Minimal vacancy in storefronts
- Recent addition of multi-family housing and second floor apartments downtown
- AirB&B's popping up in second and third apartments of downtown buildings

When discussing areas where the downtown could improve, the conversation was dominated by two subjects – "walkability" and "welcoming others".

#### WALKABILITY

While walking downtown, one can't help but notice the large volume of truck traffic around two sides of the square. It was noted a better balance needs to be struck between vehicles, semi-truck traffic, large farm equipment, and pedestrians downtown. Conflicts between these entities regarding traffic, turning movements, and parking, were described by the committee members and stakeholders alike. It was stated that the agricultural aspects of the community should be celebrated, but finding a better way to co-exist downtown was strongly desired. Traffic calming, different parking configurations, and pedestrian and bike facilities were discussed.

## WELCOMING OTHERS

Because Columbia City is positioned half-way between Fort Wayne and Warsaw, the committee feels there is potential to draw visitors from these communities to downtown for a daytrip or weekend getaway. They would like to see the variety of shoppes and dining increase to support this type of activity.

Additionally, steering committee members and youth council members agreed that although conservative, the community could be more inviting to people of different cultures, races, and sexual orientations. Concern was expressed that people may be avoiding downtown Columbia City due to that perception and that is not good for business or the larger community image.

## **STAKEHOLDER INTERVIEWS**

Three stakeholder interviews were held during the planning process. The following individuals or groups were interviewed: five teenage residents from the Mayor's Youth Council, two active downtown advocates, and two downtown business owners. Interviews were conducted in person at city hall on June 13th, 2023 and August 4th, 2023. Key takeaways from these interviews are included on the following pages.

## **YOUTH COUNCIL**

Like the steering committee members, the mayor's youth council values Columbia City for its "small town feel". They enjoy seeing people they know on the street when they walk downtown, attend a downtown festival, or visit a downtown business. The group did not struggle to develop a long list of the things they like enjoy and appreciate about downtown—a partial list is included below:

- Outstanding public art and murals
- Teen involvement in public art
- Coffee shop for hanging out/socializing
- Downtown bowling alley
- Eateries to patron with friends
- Festivals and events with food trucks
- Street Trees and landscaping
- Holiday parades and events

#### **EVERYDAY GATHERING SPACE**

Although the group spoke very highly of downtown events—First Fridays and Old Settler's Day—they admittedly had less motivation to come downtown on a typical day with no planned events. More shops geared towards teens was one suggestion as many of the shops downtown serve an older population with furniture and antiques. A social space that is walkable from adjacent downtown neighborhoods—not all teenagers own or have access to vehicles was a second suggestion. When asked what spaces they've been to in other downtowns that fit this bill, Promenade Park in Fort Wayne and Broadripple Village were spoken of highly.

#### CONNECTING THE NEXT GENERATION

Only one of the interviewees lives walkable to downtown. Others mentioned they frequently use the Blue River Trail and discussed potential further connections to downtown as well as to the middle and high school campus. Existing service activities currently connect local youth to the downtown through the Students for Life and the Key Club; however, more volunteer opportunities and activities to connect the youth to the downtown community and happenings was also discussed.

## DOWNTOWN ADVOCATES AND ENTREPRENEURS

The success of small communities typically hinges upon the motivation, participation, and dedication of a small group of individuals downtown Columbia City is lucky to have just that. Downtown advocates and entrepreneurs have been working tirelessly for years to find grants, develop programming, and recruit new businesses to the project area. Recent wins from these efforts are listed below:

- Activated alley spaces
- Landscaped pocket parks
- Grant-based façade improvements
- Successful downtown events

Common themes that rose to the top in discussions with downtown advocates and entrepreneurs included the following:

- Remove angled parking from busy streets surrounding the courthouse square
- Make parking more convenient/accessible for new businesses, restaurants, and residents.
- Recruit upscale dining options
- Improve streetscape by providing consistent lighting, better maintained trees and grates, and providing matching signage
- Require property owner accountability for building conditions and upkeep

## **ONLINE PUBLIC SURVEY**

An 18-question survey was made available to the public via social media from early-June to mid-August. 425 people responded to the survey within that time. Questions were focused to first gain a better understanding of the demographic responding and secondly to help determine priorities of the participants regarding present conditions as well as the outlook for downtown Columbia City. Select survey results are illustrated below—full survey results can be found in the appendix.

Key questions on the survey were: reasons for going downtown; what would you wish was offered or improved upon downtown; where does downtown most need improvement; what would you like to see more of in downtown; and what types of businesses would you like to see more of in downtown; and is revitalization important.


#### SIX KEY TAKEAWAYS

A review of the on-line survey found many common threads with key takeaways summarized below.

#### 1. RESIDENTS GO DOWNTOWN MOST OFTEN FOR COMMUNITY EVENTS AND DINING.

The highest percentage of reasons residents visit downtown are for community events at 84.2%, with dining a close second at 77.12%. Shopping fell far below those percentages at 40.80%.

While special community events are excellent reasons to bring crowds downtown, the occasional event cannot sustain a thriving downtown on a daily basis. Dining downtown is a popular reason for visiting downtown but dining alone isn't sufficient to encourage restaurant patrons



Walking around downtown was cited as an activity in downtown but no other recreation was given as a reason. A lack of recreational opportunities, amenities such as benches, and dog-friendly venues are mentioned as needs further into the survey but may be reasons why visiting downtown for recreation was not high on visitors' lists.

### 2. VISITORS WANT MORE DINING AND SHOPPING OPTIONS BUT NOT MORE EVENTS.

While dining was given as the second-most reason for visiting downtown, nearly 74% of respondents stated that more dining options are their most desired improvements. Outdoor dining and dog-friendly options were most often noted as the type of dining.

Shopping options was second highest in desired improvements at over 60% stating as their most desired improvements. A variety of shopping options and longer shopping hours were noted. Shopping and dining options can draw visitors downtown and keep them there longer as one activity leads to the other.

In a distant third place was more community events as most desired improvements. While most respondents cited community events as the number one reason for visiting downtown, they would rather see more dining and shopping options. Community events draw a community together, bring in visitors from outside the community and give the community an identity. They don't, however, help sustain a viable downtown on a daily basis in the way dining, shopping, entertainment and housing opportunities can provide.

#### 3. CARS GET THEM THERE BUT OTHER OPTIONS WOULD BE DESIRABLE.

Almost 90% of the respondents get downtown by car and rate downtown parking as average or good but cite parking improvements as a need in unstructured responses. Walking was below 50% in this question that invited respondents to check all that applied. To a related question regarding where downtown needs to improve, benches and bike racks received 22.33% and sidewalks and streets received 17.10% of the responses. Offering secure storage for bikes, benches for resting, and safe, accessible and well maintained sidewalks would encourage more visitors to leave the car behind.

Improving building facades and programing events were also high on the list at 26.67% and 22.8%, respectively. An attractive downtown with activities for the entire family invites visitors to downtown and offering options without driving may bring in more visitors who opt out because of parking and traffic issues.

#### 4. VISITORS WANT TO ENJOY OUTDOOR SPACES.

Outdoor dining spaces, community gathering spaces, parks and recreation all ranked high on the list of what respondents want to see more of. Dining options, especially outdoor dining was ranked high throughout the entire survey. While community events are popular, respondents resounding said give us outdoor spaces for hanging out when there is nothing else going on. Dog-friendly spaces and dog parks were especially noted, as were benches and bike racks. Likewise, when rating downtown in a variety of categories, respondents rated the city as average in business variety, sidewalks and public spaces, retail environment, bicycle mobility, conditions of buildings, parks and open spaces, and restaurants and entertainment. Comments often reflected an impression of nothing exciting to do downtown. Suggestions for improvements included more dining options, filling vacant storefronts and improving existing building facades, essentially giving visitors more variety and improving the appearance of the downtown experience.

### 5. DINING, SHOPPING, AND ENTERTAINMENT ARE IN GREATEST DEMAND.

Casual restaurants topped the list of businesses respondents wanted to see, followed by destination dining, entertainment venues and boutique retail stores. As seen throughout the survey, more restaurants, entertainment and shopping options seen as vital components of a downtown revitalization. Many cited the necessity of leaving town for the experiences they wanted to see in their hometown. More options in downtown would keep local dollars local.

#### 6. DOWNTOWN IS THE HEART OF THE COMMUNITY.

The attitude towards and impression of the city's downtown is vital in the support of a revitalization plan. Revitalization of downtown Columbia City was rated as very important to almost 64% of the respondents. Many commented that the downtown is the heart of the community, that it represents what the community is about and it should be a place of pride for the residents.



The downtown should offer a reason to go downtown and be a beautiful place to visit. While the demand for new businesses was high, the importance of preserving the historic nature of downtown and improved aesthetics was also important. Respondents cited vacant storefronts as uninviting and negatively impacting the look and experience of being downtown. While most respondents voiced pride in their community, they felt the revitalization of downtown was an important effort for the city.

- Seasonal Programming



#### **EXERCISE 2:**

The second exercise involved an interactive map of the downtown. First Friday-goers were invited to use cut-outs to invent a new downtown space. Additionally, participants were asked to provide additional feedback or comments via post-it notes and comment cards.















## **PUBLIC PRESENTATION**

On November 14th, 2023, the draft plan was presented to both the Redevelopment Commission at noon and the Columbia City Council and general public at 6:00pm. A brief overview of the planning process, public input, and draft recommendations were presented. A question and answer period followed with discussion-the following key takeaways were heard:

#### **1. DOWNTOWN ARRIVAL SEQUENCE**

Although outside of the study area, the arrival sequence into downtown from the south was brought up as a major area of concern and interest to attendees. The impressive school campus and view of the courthouse from IN-9 are a spectacular introduction to the city; however, as you move further north into downtown, parking lots are ample and various light industrial uses create a gap in the sequence that needs attention. This topic was also discussed during the planning process, and was determined it should be addressed in the recommendations section of the plan as a "bubble project".

## 2. CONFLICTS AND CONGESTION ON VAN BUREN

The frequent conflicts between parked cars and vehicular traffic traveling east and westbound along Van Buren west of Chauncey was discussed as a concern. Opportunities for a modified street section using parallel parking on one side and angled on the other was discussed as a means to widen the road and reduce conflicts between cars backing out of parking spaces and those traveling in the roadway. Bumpouts



or curb extensions were discussed as a means to reduce speed–replacing the existing signal at Van Buren and Chauncey with a stop sign was also discussed as an opportunity to slow traffic on this main east-west corridor.

#### **3. PICTURING PUBLIC SPACE**

Three locations for public space downtown were reviewed and discussed. Several commented they couldn't picture how a public space would work downtown when discussed in the past, but the sketches helped them to see how it could be possible. Others mentioned they had seen roads closed in other communities to create public space and it had an positive outcome. Concerns about circulation and parking were mentioned. Many hadn't thought about how existing restricted parking on the south side of the square will become available once the jail



moves out, which allowed the idea of removing parking in other locations seem more plausible. Although individuals voiced preferences over certain locations for the public space, a single location was not preferred or disliked overall by attendees.

#### 4. PARKING CONCERNS ARE SPECIFIC TO DAYTIME

Concerns about the lack of parking were discussed as primarily a daytime issue-if an issue at all. City and county employees are downtown during the day, most eateries, shops, stores, and offices are competing for parking during the day as well. Opportunities for shared use parking lots being made available in the evening hours was discussed. The parking lot behind the jail was also discussed as a future opportunity for more parking just a half-block from the square.

#### 5. PARKING PERCEPTIONS

One attendee mentioned they do not patron downtown restaurants unless they can find a parking space directly in front of the building. This level of standard for available parking is not something big box retailers are held to., but is a barrier downtown business owners face. City employees have deliberately moved their reserved parking spaces away from the square to make spots available for patrons. Business owners who park in front of their stores and while complaining about available parking, should follow this example.

#### 6. HOLD BUILDING OWNERS ACCOUNTABLE

Many downtown building owners are investing in their properties and making a positive impact downtown. In fact four facade grant payments were approved at the Redevelopment Commission meeting on the day of the public presentation. However, attendees expressed discouragement with many building owners who live outside of Columbia City and are neglecting their properties. Several council members stated it was time these building owners be held accountable.

# CHAPTER 05 FACADES

## **CHAPTER OVERVIEW**

Because facade funding opportunities are currently somewhat limited, the city decided not to invest in a full facade study with specific building improvements and proposed restoration renderings at this time. As new funding opportunities become available, it is recommended an architect be engaged to complete a full facade study as facade restoration is a key component of downtown revitalization. This chapter includes defined priority zones for future facade improvements as well as general recommendations for next steps related to facade improvements in downtown Columbia City.

## **PRIORITY ZONES**

The map to the right illustrates four blocks that were identified as priority zones for future facade improvements. Many of the buildings along these blocks are in good condition, but others could use attention to bring them up to a higher standard. The following pages include elevations of these blocks with general recommendations for improvements.

#### **GENERAL RECOMMENDATIONS**

1. PRIORITIZE FACADE PRESERVATION WHENEVER FEASIBLE--RESORT TO RECONSTRUCTION WHEN NECESSARY: In general, all historic buildings within the study area should be preserved in order to maintain the historic charm and character of the historic district. However, where the building structure is deteriorated or structural stability is a concern, reconstruction of the building behind the facade, or a complete demolition and reconstruction may be considered depending on the funding source. If federal or state money is used, more restrictions may come in to play.

2. MAINTAIN FACADE DETAILS TO MAINTAIN EXISTING CHARM AND CHARACTER DOWNTOWN: Some components of a historic facade that contribute to the buildings character include decorative cornices, window hoods, masonry walls, evenly spaced windows, masonry piers, transoms, display windows, and bulkheads. Property owners should be encouraged to maintain these unique elements. When original elements are beyond repair, replacements should match the same size, scale, and style as previously represented under the guidance of an architect.

3. ENGAGE AN ARCHITECT WITH HISTORIC PRESERVATION EXPERIENCE AND MAKE AVAILABLE TO PROPERTY OWNERS: In order to ensure improvements are made to buildings that follow the original scale, size, and architecture style of the original building, it is recommended the contact information for an architect with historic preservation experience be made available to property owners. This architect can be consulted on a range of topics. A local match for consulting fees could incentivize property owners to engage.

4. ESTABLISH A GUIDEBOOK FOR DOWNTOWN FACADE FOR CLARITY AND CONSISTENCY: Engage an architect with historic facade experience to develop a guidebook specific to facade restoration in downtown Columbia City. This guidebook could include topics such as window repair and replacement, masonry repair and restoration, wood maintenance, metal maintenance, decorative glass maintenance, doors, as well as community preferences for color guidelines and recommendations, awnings, signage treatments, and lighting.







FIGURE 5.1: PRIORITY AREAS OF FOCUS

# CHAPTER 06 RECOMMENDATIONS

#### **EXPERIENCING SUCCESS**

For a population of less than 10,000 people, Columbia City cannot be written off as a sleepy Indiana town. The downtown has active festivals throughout the year that draws thousands of participants. A coffee shop, bakery, brewery, several diners and restaurants, plant-based ice creme dessert shop, sushi restaurant, bowling alley, and multiple antique and gift shoppes sit within walking distance of the square.

Additionally, local special interest groups have devoted their time, and in many cases, manual labor towards smaller acts of investment like beautification of the streetscape to large investment such as renewing older buildings and encouraging entrepreneurs to inhabit them. This combined vested interest in the success of downtown from both the city leadership and the community is visible and vibrant.

Because so many of the "little things" have already been accomplished here—successful facade programs, activated alleys, well-attended events and programming, the establishment of an arts council and the implementation of several public art installations—these plan recommendations are pushing the community towards doing something "big".

#### TIME FOR SOMETHING "BIG"

"Big" things are certainly happening directly adjacent to downtown. Recent planning and design efforts have resulted grant funding for Eagle Park—a newly master planned park on the site of the old high school northeast of downtown. New phases are underway to extend the Blue River trail

further west and south of downtown. Furthermore, discussions and procedures have been underway to clean up a brown-field site and past industrial area along the river for future development south of downtown.

With the county jail in the process of moving, a major opportunity for redevelopment will open up on the south side of the square. Although many of the facades appear to be in good condition, a number of the downtown buildings are suffering from neglect, decay, and major structural issues. With such high occupancy of first-floor retail, an overhaul of the streetscape and addition of a permanent public space could take the walkability and opportunities for outdoor dining and events to a whole new level. It's time for something "big".

Admittedly, these are not small tasks—daunting in fact. But placed in the wrong hands, these big opportunities could be easily wasted. Instead, it is recommended they be taken by the reigns and pushed forward to build on the downtown success so many have worked so hard to establish.



#### **OVERVIEW OF RECOMMENDATIONS**

After reviewing past planning efforts and recent accomplishments, analyzing public input, and inventorying existing conditions, recommendations were developed in four main categories— CONNECT, ATTRACT, PROTECT, and INFORM.

This chapter provides goals and strategies within each category as well as examples of where these types of strategies have been successful in other communities as a starting point. Concepts were developed for several strategies to provide a better visualization of how they could be applied specifically to downtown Columbia City.

The chapter concludes with an implementation table, which specifically identifies next steps, budget ranges, responsible parties, and priority.

#### **PLAN UPDATES**

To ensure downtown revitalization progress it is recommended the plan be revisited and updated every 5 years. These continual tweaks will make certain the plan remains relevant, current leadership is involved and invested, and goals are clear and focused. Additionally, annual reviews with the committee and City leadership are encouraged to monitor implementation efforts and support momentum.

## CONNECTING DOWNTOWN AND THE SCHOOL CAMPUS

Throughout the planning process, discussions were had regarding how to connect the active educational campus south of downtown with the square. Physical connections, such as trails, and non-literal connections, such as involving the student population in the care and success of the downtown district through volunteer opportunities and special projects were discussed.

Many communities have a "Tree Tenders" program, which assigns volunteers to the care and maintenance of newly planted trees. This program could also involve creating an inventory of the urban tree canopy and monitoring health and longevity of trees downtown. A "Teens for Trails" program could involve students organizing temporary art or educational exhibits along the trail or even a 5K or bike ride from the campus to downtown. Teens from the Mayor's Youth Council mentioned they need a place to go after school before a football game on Friday nights throughout the fall season. "Teen Ambassadors" could organize a pep rally on the square or a game night at a local coffee shop. Activation of downtown is a multi-generational effort.




FIGURE 6.1: TRAIL CONNECTIVITY

## GENERATE OPPORTUNITIES FOR FINE DINING DOWNTOWN

Although downtown has many eateries, there was an overwhelming ask from the public and the committee for a fine dining option. Strategies to move towards this goal are outlined below:

- Incentivize established county restaurateurs to develop a downtown satellite location:
- Ensure new builds can accommodate restaurants and not just commercial, office, or retail uses: Restaurants require specific fittings including sprinkler systems and grease traps. These accommodations would be costly for a new entrepreneur to retrofit themselves and could be a deterrent.
- Re-imagine existing buildings as restaurants. The PREWITT in Plainfield, Indiana is an example of a re-purposed theater turned restaurant and lounge with rooftop dining and a small music venue.

## **EXPAND EVENING PROGRAMMING**

Outside of First Fridays, most evenings the sidewalks downtown are free of people. This could be due to existing store hours and the busy evening activities many families are consumed with such as youth sports. Suggestions heard at the public input sessions were to develop street dances or free concerts to attract people downtown for dinner and entertainment. An open mic night could attract performers and their families to patron downtown more often.

#### ENCOURAGE SEASONAL OUTDOOR DINING

Many communities with chilly weather have still found ways to provide an interesting dining experience in the winter months. Freestanding, portable heaters are typically just enough to stretch the fall season for outdoor dining. Temporary, plastic igloos can take "outdoor" dining into the winter months by providing a toasty private setting for dinner under the stars with a view of the courthouse architecture.

#### DEVELOP WINTER PROGRAMMING TO ACTIVATE THE SQUARE

Fair Oaks Farm sets up an ice rink and "Arctic Blast" slide each winter to attract families for winter fun. Combined with holiday shopping and some popup outdoor eateries could be enough motivation to bring people out into the cold during the holiday season. With the sun setting before five o'clock on many winter nights, interactive lighting could attract people to explore the downtown sidewalks prior to grabbing dinner at a downtown eatery. Interactive lighting provides a unique experience each time you visit with motion sensors setting off only when people are present.









#### **INDOOR ATTRACTIONS**

Families with children are typically looking for things to do that are close by. The Wonderlab in Bloomington is an example of a small children's museum that has become a place people from outside the community now travel to. This type of facility would be a great place for local teens to work or seniors to volunteer bringing people of all ages downtown. An indoor climbing or play space would also satisfy the desire for a place to host birthday parties downtown.

The Peabody Public Library is an outstanding amenity for residents located just east of downtown. If a satellite branch were established in a small storefront downtown, it could host children's programming and after school study sessions, tying that amenity to the center of the community.

# CASUAL OUTDOOR DINING & SOCIAL SPACES

Lafayette has implemented a seasonal outdoor dining program that involves creating a temporary, removable deck at the same height as the sidewalk curb in specific parking spaces downtown. These spaces increase dining space for local restaurants during the summer and fall months and are removed the rest of the year. This concept could also be used for seasonal, temporary public art space or casual outdoor social spaces or miniplazas to encourage people to come downtown and stay awhile during the warmer months.

Establishing a more permanent food truck court was something rated highly in the public input process as something downtown Columbia City should consider. When combined with movable seating, a social gathering space is created.











#### **PERMANENT PUBLIC SPACE**

Most major festivals and events held downtown today require a street closure. Much of the feedback received during the planning process pointed towards the desire to have a permanent public space downtown that could be a central gathering space standing on it's own even if no planned events are taking place.

Critical components of this type of public social gathering space might include the following:


- Flexible programming space.
- A fountain or splash pad.
- A play structure or play space.
- Outdoor game tables such as ping pong.
- Social seating and shade.
- Flexible, programmable plaza space.
- Event lawn, trees, and landscaping.

Three locations for a permanent public space downtown were explored during the study. Each location would include a combination of these similar components. Concept plans of each location can be viewed on the following pages:





#### GATEWAYS

During the planning process, the importance of a strong entrance sequence from the city limits to the downtown district was brought to light. The existing school campus and views of the courthouse are strong, but other areas leave something to be desired. The next two pages explore potential improvements for the arrival sequences from the south, west, and east. Although outside of the study area, this discussion had value and has been identified in the plan as something of high priority to explore as decisions regarding development and improvements in these areas are decided in the future.






FIGURE 6.3: STREETSCAPES & FACADES




FIGURE 6.4: DISTRICTS & REDEVELOPMENTS

## STRUCTURAL IMPROVEMENTS & CODE ENFORCEMENT

Historic facades define a downtown's character and charm. Without them, programs like the Digital Historic Walking Tour would be less of a draw. A general concern for the structural stability of many buildings downtown is known, but in order to address the problem, the issues should be more formally recorded. It is recommended the city lead a structural assessment of buildings downtown. This would be voluntary participation by property owners, but may help identify how critical the issues are. Once inventoried and prioritized, the process for seeking out funding sources could begin. Structural issues don't qualify for most available facade funding programs, so funding may need to come from private investors with matching incentives from the city. A review of existing codes should also take place to understand if neglect of existing buildings can be enforced.

## PHASED STREETSCAPE

It is important to develop a streetscape masterplan, so phases can be implemented overtime with consistency. A streetscape masterplan would dive more deeply into design considerations for parallel versus angled parking, where to establish bumpouts or curb extensions, and would develop a preferred set of design guidelines for items such as seating, planters, lighting, bike racks, litter receptacles, signage, trees and landscaping. This plan could also take below ground infrastructure improvements into account when developing phasing. More grand and/or interactive planters were also discussed as ways to beautify the streetscape and encourage "citizen scientists" to assist with counting pollinator activity downtown.

### **TEMPORARY ART**

"Umbrella Sky", a temporary public art installation in Batesville, Indiana was so popular, vendors at the Farmer's Market saw a 30% increase in sales during the time frame it was installed. Every two years, Greenwood sends out a call for artists to either create new artwork or temporarily lend their existing artwork to the community for installation on preset foundations along a section of their trail. Permanent public art can be difficult to agree on--temporary artwork is easier to negotiate. Nonpermanent art installations will attract visitors from outside the community as well as give residents a new reason to go downtown during a set period of time.

### **DISTRICT DEFINITION**

By defining a district north and south of the square, guidelines can be used to direct development. Steering mixed-use and multi-family to the south would allow for the district north of the square to encourage more owner-occupied housing improvements and retail within renovated homes. There are opportunities to restore natural areas along the Blue River to the south creating a greenway and gateway for downtown.

#### PURCHASE PROPERTIES

What happens with the Whitley County Jail property will greatly impact the next chapter for downtown Columbia City. When the opportunity arises, it is recommended the Redevelopment Commission purchase the property and work with a consultant to develop a Request for Proposal outlining the type of redevelopment that is preferred on this prominent block.

- Number of times on Friday where students go to the high school football game --- starts at 7:00 and they want something between evening school activity and start of game... get something to eat, Brew-ha, walk on trail... what else to do downtown??? Find an active space for ping-pong and other "yard game" activities for teens and others
- There needs to be more than one reason to get to downtown... especially for families to load into the car and visit. There needs to be at least three things to convince them... ice cream, walking the shops, and vard games for example.

#### Spaces for activation???

- Jail land --- mayor knows there has been minor conversations on the side about the future none
  of the commissioners have provided an indication. Mayor will not buy the land but will allow the

- Preserving main street opportunity through OCRA grants --- Columbia City's robust façade program has provided nice street front but need money for roofs and foundations and 2<sup>nd</sup> and 3<sup>rd</sup> story renovations --- preserving main street grant through OCRA is JUST façade and streetscape.
- Apartments for workforce housing on upper levels?
- OCRA will not touch upper-level living spaces because they do not have the capacity to administer HUD dollars for housing.
- o Property owners have the space but not the funds to invest in upgrades for rentable, usable space.
- Columbia City Façade Grant owner applies and City pays for a portion but a business owner has to pay upfront 100% and then get reimbursed which can be a challenge.

  - Yes, need restaurants for dinner/entertaining clients
  - Larger offsite meeting space
  - Chauncey Street closure idea Concept 1
  - Could that include converting traffic signal to three-way stop?
  - Public space downtown should definitely be part of plan
  - Like idea of it being connected to city hall
  - Could both sites be combined showing both ideas (north and south of Van Buren)
  - Committee does want a concept of public space on the jail site
  - Star Bank has basement with large meeting space, kitchen, bathrooms that is available for rental/events

#### PROTECT

- o Nobody is proactively trying to acquire problem buildings
- Lots of rear additions were never built well and are the most dangerous
- Idea discussed to tear some of rear addition off to remove danger and create parking
- Streetscapes are very important
- 200 block of west Van Buren could shift one side to parallel parking to gain additional space for larger trucks/safer backing up into traffic
- o Star Bank owns two surface parking lots, one is very underutilized
- o Bank did sign some spaces for employees only, but nearby retailer complained
- Façade program amount per bldg. is less now that it used to be, went several years without anyone requesting funds
- o Had issues with people making them look a little better but not any more useful/valuable
- EDC revolving loan fund haven't had local interest lately (currently one in South Whitley)
- Need to use carrot and stick approach at same time
- Once figure out what grant you're eligible for, may be too far into process
- Need to help bldg. owners understand/educate







## Q3 Are you a downtown business owner?





## Q8 How do you typically get to and around downtown? (check all that apply)


